We have partnered with <u>Cuyahoga County</u> for Sewer & Sanitary Waste Removal Services beginning October 18, 2023 through April 17, 2026.

This contract does NOT include Pit Toilets. Those services are currently provided by United.

Golf Courses are NOT included in this contract.

Current Rate Schedule (subject to change during contract term) is included below. Fee structure is based on:

- 1) County Services performed
- 2) NEORSD Waste Disposal Rates for <u>Grit</u> (current \$140.15/ton) and <u>Non-Grit</u> (formula-based fee will fluctuate depending on flow and suspended solids)
- 3) NEORSD Analysis/Testing Fees of Non-Grit Waste as warranted (1 Lift Stations located at 5555 N. Marginal, 7301 N. Marginal and Edgewater Marina; 2 Sea Lion Pits at Zoo)
 - **All invoicing will come from the County on a monthly basis. NEORSD will invoice the County for "waste disposal fees" on a monthly or quarterly basis (depending on type of waste) and the County will then invoice Cleveland Metroparks for disposal fees. Disposal fee invoices will likely be at different intervals than the County's actual service invoice. Please issue ONE Purchase Order to Cuyahoga County for all fees.
